HAWAIIAN PARADISE PARK SCHOLARSHIP PROGRAM 2024/2025

Mālamalama Waldorf School has a lease with Hawaiian Paradise Park that includes a provision for tuition scholarships for homeowners in HPP. This scholarship is for one year only.

The HPP Scholarship Awards are determined based on a rating sheet completed by the Tuition Adjustment/Scholarship Program Committee. Information for this process is received from the HPP Scholarship Adjustment application, FACTS Grant Aid assessment, Tuition Adjustment/Scholarship Program Application, Income Expense Worksheet, information from the Hawaiian Paradise Park Owners Association office regarding your volunteer work with HPP, our Business Manager's report on payment history for all accounts, teacher's report of family participation in class, date of app submission, and the school's completed volunteer log or payment of the Volunteer Service Fee.

Policy Statement:

- ☑ While MWS expects families, or extended families, to take primary responsibility for the cost of their children's education, we recognize that financing a private school education may be a challenge for some families. The Hawaiian Paradise Park Owners Association and MWS are committed to helping families afford this choice. The HPP scholarships are available for HPP residents, which are granted on the basis of need and other criteria including but not limited to the following:
 - History of timely payments
 - Applications must be submitted by the deadline (April 15, 2024).
 - FACTS Grant Aid assessment
 - Number of children in family attending MWS
 - Family involvement in school and class
 - Family involvement in HPP
 - Student's academic performance, attendance/tardiness and behavior.
 - Homeowner in HPP
- ☑ Only forms that have been thoroughly completed and have all requested documentation will be processed.
- ☑ **Applications received after the deadline of April 15, 2024 are ineligible for awards, regardless of need.**
- ☑ **Students who are fortunate enough to have trusts, grandparents, non-custodial parents, or friends willing to pay their tuition should not apply for these scholarships in order to ensure that students without such resources have access to these funds.**

Eligibility:

- ☒ Students who are entering grades 1 through 8. Special consideration may be given to students in Kinderhale if they have a sibling in the grades or other special circumstances.
- ☒ Resident of Hawaiian Paradise Park (copy of Real Property Tax stub required).
- ☒ Limited availability of other resources.
- ☒ All previous accounts with the school must be in good standing.
- ☒ All 2024/2025 Enrollment Fees paid.

Procedure:

- ☒ Submit completed Tuition Adjustment Program Application to MWS by April 15, 2024. **The FACTS Grant Aid assessment may take up to 4 weeks.** Please submit forms to FACTS upon receipt of this application. (A determination cannot be made without the assessment from FACTS Grant Aid). If the completed application is not received by the deadline the request will be dismissed.
- ☒ Once the completed Tuition Adjustment Program Application and FACTS Grant Aid assessment are reviewed, the Tuition Adjustment Committee will schedule a meeting with the family. Generally, at the end of the conversation, an agreement is reached specifying the family's contribution for the school year. This adjusted tuition amount is presented to the Tuition Adjustment Committee for final review after which the family will receive a determination letter.
